## General Terms and Conditions for Participation

- 1. Equipped stands include:** a glass-case (100/100/50); a table; 2 chairs; two shelves; a lighting fixture; 220 V electrical supply; general and local lighting; heating and ventilation; overnight security services; cleaning of the common areas; entry passes.
- 2. Participation fee includes:** a copy of the exhibition catalogue, two badges, unified sign and inscription for the stand made of self-sticking folio. For preparing of the above folio the sign should be sent in Corel Draw format by e-mail to: [meridian22@intech.bg](mailto:meridian22@intech.bg).
- 3. Advertising page in the Catalogue:** participants should send the color advertising page not later than 1 February 2011. The page size should be: height-16.5 cm, base-11.0 cm. The file could be in .jpg or .tif or .eps format (whatever you prefer) but in high resolution - 300 dpi.
- 4. Duration of Forum - 3 days** - from 25 to 27 February 2011 including. The Exhibition will be open for visitors **between 10:00 AM and 7:00 PM**. Exhibition working hours are from 09:30 AM to 07:30 PM. The last day - 27 February, working hours are from **10:00 AM to 6:00 PM**.
- 5. Stands and exhibits will be arranged** on 24 February 2011, from 01:00 PM to 06:30 PM, or on 27 February 2011 from 09:00 AM.
- 6. Transport of the exhibits** to the stands and the arrangement of the stands is the Exhibitor's responsibility.
- 7. The Organizer provides night security** services for the time of duration of the Forum. Within the working hours the Exhibitor is responsible for his own exhibits.
