- 5. Stands and exhibits will be arranged** on Thursday, March 4, 2010, from 01:00 PM to 06:30 PM, or on Friday, March 5, 2009 from 09:00 AM.
- 6. Transport of the exhibits** to the stands and the arrangement of the stands is the Exhibitor's responsibility.
- 7. The Organizer provides night security** services for the time of duration of the Fair. Within the working hours the Exhibitor is responsible for his own exhibits.
- 8.** Exhibitors will be responsible for any damages caused by them to the construction, flooring and rented equipment. Damages should be paid prior to release of stand.
